(1) an immediate Secretary of State investigation of the fact that my voter registration affiliation on the CO Secretary of State website was changed by an unknown person from Republican to Unaffiliated between April 9, 2022 at 11:47 PM and April 11, 2022 at 10:31 AM; and

(2) an immediate Secretary of State investigation of the conduct of Kristi Burton Brown, Chairwoman of the Colorado GOP (Chair) and Priscilla Rahn, Co-Chairwoman (Co-Chair) and George Brauchler in this matter, as their actions have influenced the primary election outcome in a way which may violate state and federal election laws; and

(3) immediate Secretary of State Certification that I am a Duly Designated Candidate for the Republican Primary Ballot for Colorado Attorney General.
